2.0 **PROFICIENCY**

2.1 OCCUPATIONAL HYGIENE

Occupational hygiene is concerned with the recognition, evaluation and control of health hazards in the workplace. Our staff have extensive experience in both the traditional areas of occupational hygiene within industry, and the investigation of occupational health matters with office environments. Staffs available are qualified and experienced at dealing with: Chemical agents such as dust, gases, vapours, fume and mist; Physical agents such as radiation, lighting, temperature, noise, biological agents such as air/water-borne micro-organisms, pest and rodents.

Assessment of the Problem

Occupational hygiene reviews are conducted to identify health hazards (chemical, physical, biological, ergonomic, psychological) and specify the work required to evaluate the risks, or to advise the client on action required to comply with specific legislation such as the control of Substances Hazardous to Health Regulations, or the Noise at Work Regulations federal Ministry of Environment (FMENV)

FMENV Regulations require that employers make an assessment of the health risks arising from work with hazardous substances in order to identify the measures required to comply with the regulations and the risks.

Having identified the work required, Environmental & Chemical Services Limited will assist with implementing any or all of the recommendations including monitoring, sample analyses, training and follow up assessments.

Surveys and Monitoring

The exposure of individuals to specific hostile agents in the work place is measured and the effectiveness of existing control measure is assessed.



Advice on Control Measures

Monitoring can be conducted to enable employers to demonstrate compliance with Maximum Exposure Limits and Occupational Exposure Standards.

We provide advice on the measures necessary to control health risks and help implement these measures. Control may be achieved by engineering means, use of personal protective equipment, procedural changes or a combination of these.

Training

We can help with training in a variety of ways from providing information and training packages for clients' own staff to presenting lectures or small group workshops. Also we can develop and conduct environmental awareness programmes to meet clients needs.

2.2 ENVIRONMENTAL ASSESSMENTS

Environmental & Chemical Services Ltd, environmental specialists have extensive experience in the assessment, analyses and control of a wide range of chemical, physical and biological agents in the external environment.

Consultants are qualified and experienced in dealing with: Environmental Impact Assessment (EIA) Environmental Audits, Environmental Evaluation Report (EER), Post Impact Assessment (PIA) etc

Identification of the likely effects of new developments for the purpose of planning inquiries or in preparation for presenting new proposals to government bodies, planning departments or industrial or neighborhood communities.

Air Pollution Modeling

Prediction of air pollution levels utilizing air modelling techniques for many points, line and area source emissions.

Air Quality

Air quality and process stack emission analyses, with subsequent recommendations and supervision of control measures, ambient air quality monitoring and roadside monitoring of vehicular pollutants.

Air Monitoring and stack emission measurement

In conjunction with our supervision of special waste removal we can undertake stack monitoring, provide expert report of pollutants entrained in the stack emission.

Water Quality

Water Quality and process effluent analysis and recommendations on water treatment regimes. This includes ground water studies.



Contaminated Land

Identification and evaluation of the degree of pollution on site. This commence with the initial site appraisal, analyses, through to subsequent proposals for remedial action and supervision of remedial site work.

Hazardous/Special Waste

Hazardous/Special Waste handling and disposal, (recommendations and supervision). This is a field where technology is developing along with public perception of the need for effective waste management. Originally limited to crude landfill, methods have come to include controlled landfill, neutralization and incineration.

The latest approach is to consider whole processes concentrating on waste minimization or "clean technology" and avoiding "end of pipe" solutions.

Noise and Vibration:

Environmental noise and vibration measurements and assessment of nuisance and disturbance. Prediction of noise and vibration Impacts and design of remedial measures.

Radiological Protection

Radiological protection from baseline monitoring of soil, water, crop and foodstuffs. As much as anything, regular monitoring can give positive assurance where there is negligible effect; without these figures local concern could lead TO unmanageable public pressures.

Corporate Environmental Audits

- To identify all potentially dangerous emissions to the ENVIRONMENT (air, water, or solid waste) and comment on control strategies and compliance with current legislations.
- To evaluate the effectiveness of the company's environmental management



2.3 WASTE MANAGEMENT

Project Management

The complete handling of waste management from original identification, recommending remedial action, writing technical specifications, obtaining competitive tenders, monitoring work progress and compliance with current HSE Guidance and Legislation to final clearance testing.

We are often involved on behalf of clients in discussions with Regulatory enforcement officers, environmental Health Officers, and agencies, thus ensuring the smooth running and successful completion of hazardous and special waste removal programme.




